

#### HEPWORTH FETE AND HALL HIRE

Firstly may I congratulate the organisers of the Hepworth Fete for all their effort and hard work in raising £1200 for the air ambulance and the church.

I do however feel that I have to make a comment on the remark printed in the Four Gazette last month (unsigned) from which I quote :-

'We managed to raise the goodly sum of £1200 for the East Anglian Air Ambulance and the Church, even with the additional costs of the hire of the Village Hall and the Playing Field this year.

Quite what is meant by this is I am not sure! Did they not have expenses last year? I suspect that the costs were far greater in the hiring of marquees, toilets etc. than the £90 charged for the use of the Village Hall and the Playing Field from Friday lunchtime.

I know from comments from some of the organising committee that they felt that the hall should have been free as they were raising money for air ambulance and the church but I hope the following will be an explanation as to why a charge was made.

The village hall was bought and paid for by the residents of the village. Apart from many fund raising activities a 'levy' was charged on the rates (agreed at a meeting in the school). The charity status was granted in 1982 and under the object framework it clearly states that the hall and playing field is and I quote:-

'for the benefit of the inhabitants of the Parish of Hepworth'.

Now whilst I accept that Air ambulance is a charity well worthwhile supporting I don't think it can be classified as being directly for the 'benefit of the inhabitants of Hepworth' as it is for the benefit of Suffolk as a whole so I don't think that could be a reason to offer the hall for free. There is another reason of course and that is one charity is not allowed to give to another and offering the hall free of charge would have been a gift (I did phone to confirm this).

As far as the Church is concerned it is far more difficult as I think it

It could then be justified as 'for the benefit of the inhabitants of the Parish of Hepworth'.

I do hope this is taken as an effort to explain the situation and not as a criticism of any person or committee. I take my hat off to anyone who organises something for the village and will always try to support them. If I can be of help or give further information then please feel free to contact me.



#### **HEPWORTH PARISH COUNCIL**

The meeting of the Parish Council took place on Thursday, 3<sup>rd</sup> September July 2009 at the pavilion. The meeting was chaired by Mr Stannard. Amongst the matters discussed were:

Report from Borough Councillor The report covered the Local Development Framework consultation events and the implications of the proposed designation of Hepworth; the forthcoming Countryside Forum; SEBC's response to the Waste Core Strategy being concerns about traffic and road usage; and the halting of the Local Government Review whilst the Boundary Committee appeals.

**Report from Community Police Officer** The report drew attention to four recorded crimes since 6<sup>th</sup> August, namely incidents of criminal damage to motor vehicles on 14<sup>th</sup> August, and the theft of a wheelbarrow.

Ownership of Ditch behind Bus Shelter The Clerk will confirm to Suffolk CC Highways who owns the ditch behind Willow Green bus shelter, with a view to flooding being reduced.

Planning Application – Windy Hall, Church Lane The application for the erection of a) a single-storey extension, including double car port to front, b) a 1½ storey extension to the side, and c) a two-storey extension to the rear (revised scheme to SE/08/0563) was considered, and no objection or observation was recorded.

Report from County Councillor The report covered the County Councillor's formal response on the Waste Core Strategy consultation (ie Shepherds Grove is the wrong place because of its situation) and the additional steps required before a plant could be installed (huge requirement for finance, commercial viability, and planning permissions). It also covered false allegations about planning permission for County Mulch, and possible road safety improvements to the A143 / Sumner Road junction.

Accounts for Payment It was agreed to make payments to the Clerk for her salary and expenses, to the internal auditor for the 2008-09 audit, and to the insurers for the 2009-10 premium.

**External audit of 2008-09 Accounts** Additional information required by the external auditor was agreed and the documentation duly signed.

<u>Clerk's Report</u> The report covered options for three-month notice interest-bearing bank accounts, next steps regarding a safe code of practice for risk assessment and accident investigation, quotations received for the clearance of vegetation from the bus shelter outside the Half Moon, the proposed revised timetable for the mobile library service, how the informal public meeting regarding the Waste Core Strategy consultation would be handled, and insurance quotations received.

**2012 Diamond Jubilee** As the Parish Council had backed Silver Jubilee and VE Day events and as the Social Club has little financial support, the next meeting will consider whether to offer backing for any Diamond Jubilee celebrations.

<u>Bank Account at Barclays</u> It was agreed that the bank signatories should be reviewed annually, when Parish Council representatives to other organisations are elected.

<u>Parish Action Planning Items</u> It was agreed to hold a police open morning on Saturday, 3<sup>rd</sup> October for all villagers, and to hold the next Parish Action Planning meeting on Thursday, 4<sup>th</sup> February.

<u>Overgrown Hedge in North Common</u> Mrs MacPherson will ask the owners to cut this back.

<u>Dead Elms in Church Close</u> Responsibility for the removal of 15-20 dead trees are in the hedge is with the owner(s) of the bungalows, and can be carried out now that the crop has been harvested. It was also noted that someone had been filling up the essential drainage ditch with soil.

<u>Date of Next Meeting</u> Thursday, 5<sup>th</sup> November at 7.30 pm

#### **HEPWORTH PARISH COUNCIL**

The planning meeting of the Parish Council took place on Wednesday, 16<sup>th</sup> September 2009 at the pavilion. The meeting was chaired by Mr Stannard. Amongst the matters discussed were:

Old Stores Cottage, Church Road A planning application for the erection of a first floor side extension was tabled, and the Parish Council agreed to record no objection, and observed that visibility at the junction would be improved if the hedge were replaced by a low wall or set back to offer a slight splay.

<u>Waste Core Strategy – Final Consultation</u> The Parish Council asked the Clerk to draft a letter, based on the main points of concern listed below.

Transportation: Objective 3 as stated in the Strategy is "to facilitate the efficient transportation of waste throughout Suffolk". The converse to this objective would be achieved because a) of the position of Shepherds Grove within Suffolk in relation to the main population centres, b) the road infrastructure is unsuitable and minor rural roads are already being used by HGVs (this unacceptable situation would worsen), c) the A143 should not be classified as part of the Strategic Lorry Route Network as it is single-carriageway, it has many dangerous sections and accidents, and the proposal would result in an increase in traffic, and d) there is no railway link which would be a preferred method of transportation.

Other objections to be included in the letter relate to the ambiguity about the location of the 5 hectare site; the unsuitability of having the site near the Sumner Road/A143 junction; the suitability of the site for light industry with high employment only; overall ambiguity and lack of information, making it impossible to raise valid objections; concerns about setting a precedent for additional wasterelated businesses; a suggestion to consider the preferred logistical suitability of Suffolk Business Park, Bury St Edmunds; and concerns raised by villagers about transport, visual impact, health, pollution, and location.

Waste Core Strategy (Final Consultation) and Sustainability Appraisal – July 2009 Shepherds Grove Industrial Estate, Stanton as a Strategic Site

After consultation with the villagers and within a recent Parish Council meeting, Hepworth Parish Council writes to express its concerns in connection with the above consultation.

Objective 3: One of the stated objectives of the Strategy is "to facilitate the efficient transportation of waste throughout Suffolk".

Points a) to d) below demonstrate that the converse to this objective would be achieved.

- Position within the Suffolk: Although the proposed sites would be intended to treat waste from Suffolk, the Shepherds Grove site is close to the Norfolk border and has poor road connections to the main population centres of North and West Suffolk, especially to Stowmarket and towards Thetford.
- Road Infrastructure: It is a fact that HGVs are already using unsuitable, rural roads through villages for existing business. HGVs use not only the A143, but also the B1111 (Stanton to Garboldisham road). Because they cannot use the B1113 (Ixworth to Tostock road) without a special licence, HGVs also use minor roads through Elmswell and Badwell Ash. Also it is thought that heavy traffic is not permitted along the Euston section of the A1088, which means that they use the minor roads instead. Such heavy traffic, which is already unacceptable, would only worsen if a waste treatment facility were installed at Shepherds Grove.
- c) Traffic and accidents on the A143: At present, the A143 is unsuitably classified as part of the Strategic Lorry Route Network. The road is single-carriageway, and has many dangerous sections. In Hepworth, the proposal would result in an increase in traffic and accidents at an already dangerous junction of Sumner Road and the A143.
- Rail Access: There is no railway link which would be a preferred method of transportation.
- e) <u>Buffer Protection Areas</u>: It is not clear where the proposed 5 hectare site would be situated, but, if the selected site were to be at the corner nearest to the Sumner Road/A143 junction, this would leave insufficient space in which to insert any roundabouts on the A143. The proposal is ambiguous.
- g) <u>Suitability of Industrial Estate</u>: The site is suitable only for light industry which has a higher employment potential than a waste industry. It is unsuitable for heavy industry.

- h) Ambiguity and Lack of Information: The documentation tabled and answers received at consultation meetings make it impossible to raise specific objections because the proposals themselves are not specific or concrete. There is a fear that, if and when specific proposals are received, it may be too late to raise objections which could influence the outcome because any decision may be a foregone conclusion.
- i) Setting a Precedent for Waste Development: Once the sites have been allocated, such sites could offer an open invitation to all those who are interested in carrying out waste-related developments. Developers may see this as an open cheque to allow any such developments with very little control.
- j) Suffolk Business Park, Bury St Edmunds: St Edmundsbury Borough Council has recently circulated its Local Development Framework: Core Strategy submission Document dated August 2009 to parish councils for comment. Item 4.104 of this Strategy Document mentions the provision of a 68.28 hectare Suffolk Business Park with quality, well-serviced sites to the east of Bury St Edmunds with direct access from the A14. As this site is allocated as an employment area and is more conveniently located with good access to lorry routes, it is considered to be more suitable than Shepherds Grove, and should be considered instead.
- k) Concerns within the Village: A large proportion of the village population has objected to this proposal both individually and collectively, and the main concerns expressed by those villagers who attended an open meeting on 11<sup>th</sup> September covered transport, visual impact, health, pollution, and location.

Thank you for taking account of the above comments when considering Shepherds Grove as a strategic site for a waste treatment facility.

#### Swine flu vaccine rollout imminent

The swine flu vaccination programme will be rolled out over the next few weeks, say public health professionals at NHS Suffolk.

Once the vaccine has been distributed according to national plans, GP practices will contact members of the community identified as being in the priority groups by letter, inviting them to come forward for the vaccine.

The priority groups are listed below and will receive the vaccination in this order:

- 1. People aged over six months and under 65 years in current seasonal flu vaccine clinical at-risk groups.
- 2. All pregnant women, subject to licensing conditions on trimesters.
- 3. Household contacts of people with compromised immune systems e.g. people in regular close contact with patients on treatment for cancer.
- 4. People aged 65 and over in the current seasonal flu vaccine clinical at-risk groups. This does not include otherwise healthy over 65s, since they appear to have some natural immunity to the virus.

Vaccination of frontline health and social care workers will begin at the same time and will continue for as long as necessary.

Dr Brian Keeble, flu director at NHS Suffolk, said: "Although the virus has so far proved to be mild in most people, for others it has been more serious. By vaccinating these high risk groups first we are aiming to protect those most vulnerable to this virus.

"The plan is that all people in these priority groups will be invited for vaccination by their GP before the end of November – and of course, everyone can do their bit to prevent the spread of swine flu, simply by washing their hands properly and regularly."

If you are ever unsure about a company or caller claiming to be from a utility company. Never provide personal information, especially not your bank or banking card details

Verify the callers details including their name, position within the company they say they are working for and their contact details, so that you can check them independently

If the caller claims that you agreed to a particular advertising contract or promotion and you can't recall agreeing to such commitments, question the caller as to when and where you allegedly made such agreements and how they would be paid.

Genuine lotteries never ask for payment to process any winnings, they would not as any money you genuinely win is yours.

#### SCAMS - THEY NEVER REALLY GO AWAY

Suffolk Police often get contacted about the never ending scams going around, a lot of which return time and again, such as the classics "You have won on the lottery", just send us a cheque for 'X' amount to pay for the clearing fees and we will send you your winnings right away. Or "You have won a holiday", but we need you to pay the administration fees, so send in a cheque.

A particularly nasty Scam has been the telephone one, where a person has been purporting to be from BT, telling the customer that they are behind in their payments and that if they don't pay immediately over the phone by debit or credit card, they will be cut off.

The caller also asks for security questions such as your date of birth etc.

No utility company would just cut people off like that, without a number of written warnings.

#### About swine flu

Most swine flu cases have been mild, with symptoms similar to those of seasonal flu. Only a small number of people have had more serious symptoms. you or a member of your family has a fever or high temperature (over 38°C/100.4°F) and two or more of the following symptoms, you may have swine flu:

unusual tiredness

headache

runny nose

sore throat

shortness of breath or cough

loss of appetite

aching muscles

diarrhoea or vomiting

# **Checking symptoms**

It makes sense to have a working thermometer at home, as an increase in temperature is one of the main symptoms. If you are unsure how to use a thermometer, advice is available on NHS Choices at <a href="http://www.nhs.uk/">http://www.nhs.uk/</a>. If you are still concerned you may have swine flu, stay at home and check your symptoms using the online National Pandemic Flu Service: <a href="https://www.direct.gov.uk/">www.direct.gov.uk/</a> pandemicflu

**Call your GP directly if** you have a serious existing illness that weakens your immune system, such as cancer, you are pregnant, you have a sick child under one, your condition suddenly gets much worse or your condition is still getting worse after seven days (five for a child)

#### The National Pandemic Flu Service

This is an online service that will assess your symptoms and, if needed, provide an authorisation number that can be used to collect antiviral medication from a local collection point. For those who do not have internet access, the same service can be accessed by telephone on:

# Play your Part to keep fireworks fun

As the dark nights draw in, we can look forward to seasonal events such as Bonfire Night. Traditionally, this is the time to enjoy fireworks, but increasingly they are used all year round to celebrate many occasions

While most people enjoy fireworks responsibly, in the wrong hands they can cause real misery through anti-social behaviour. Many adults and children suffer fireworks injuries either through accidents or intentional attacks.

Letting off noisy fireworks late at night with no regard for neighbours can cause distress by frightening people and pets, while a dangerous minority deliberately use fireworks to intimidate residents and damage property.

The laws against firework misuse have been strengthened to protect communities and provide more powers to tackle the problem locally. Misuse offences relate to throwing, possession and controlling when fireworks are used, and other laws regulate the supply and sales of fireworks.

# Did you know?

- It is an offence to set off fireworks in public places such as parks, streets and school grounds and they should not be sold to young people.
- You cannot set off fireworks between 11pm and 7am, except on 5 November, Diwali, New Year's Eve and Chinese New Year, when the curfew is extended to 1am.
- Offences carry fines of up to £5000, or six months imprisonment and a range of anti-social behaviour orders (ASBOs) may be used to prevent fireworks misuse by persistent offenders.

Ghosts & Ghouls & things that go bump in the night......

Halloween can be harmless fun, but sometimes members of the community can become distressed by unexpected callers. Police are urging residents to display specially designed posters if they do not want to be disturbed by trick or treaters this year. Trick or treaters are asked to show respect and move on if they see one of these posters.

The posters are now available and can be downloaded and printed from the Suffolk Police website and then displayed in windows or doors of homes. These are also available from your Safer Neighbourhood Team or the front desk of your local Police Station.
